  - Help with product launches: structuration, closing, equalization.
  - Review quarterly portfolio reporting pack (valuations, cash flows, and CAS prepared by administrators).
  - Provide administrative support to the local investment team, RFPs, DDQs, Investor Questions.
  - Maintain active relationships with third-party service providers such as administrators and banking relationships.
